The College of Health Sciences currently lacks the formal mechanisms to allow a student to graduate from the CHS Dean's Scholar Program with an Honors Degree. We have found that those undergraduate students who are both interested in and qualified to complete a Dean's Scholar Program are **often also** interested in and qualified to pursue an Honors Degree; we would like to have this option available for CHS students. According to the University Catalog and other information, it is an option for students in the Colleges of Arts and Science (p.92), Agriculture and Natural Resources (p.71), and Human Services, Education, and Public Policy (p.215).

Program Requirements:
