The following resolution was unanimously approved by the Undergraduate Studies Committee on September 20, 1973:

Resolved that the Faculty Senate eliminate History 203 as a general University requirement, and that it bring University regulations with regard to this course into conformity with recently revised State legislation.

Resolved that the Faculty Senate require that the University provide an elective course in Delaware History and Government for all undergraduates and require this course of all education students preparing to be social studies teachers. This course will also be offered as an inservice program for teachers who received their professional preparation outside the state.

Resolved that this change be made effective immediately and applied to all students attending the University.

RESOLUTION FROM EXECUTIVE COMMITTEE OF THE SENATE

WHEREAS:

- 1. A motion to replace Prof. Morton M. Denn as chairman of the Committee on Promotions and Tenure has been submitted by Prof. Brabner to the Secretary of the Senate to be included on the agenda of the regular October meeting of the University Faculty; and
- 2. The Constitution of the Faculty (IV-14) says, "The Senate shall have the authority to establish such committees of the University faculty as are required to carry on its business and shall determine the methods of their selection"; and
- 3. The Senate Bylaws and Regulations (C) establish the Committee on Committees and charge it with the "general oversight of the committee system of the Faculty," including among other things "supervisory functions that will promote the effectiveness of faculty committees according to their charges;" and
- 4. No formal request has been received by the Committee on Committees to exercise its supervisory role in an examination of specific misconduct by Prof. Denn, nor to evaluate the qualifications of the proposed alternate; therefore be it

RESOLVED: The Faculty Senate accepts its responsibility to examine allegations of possible misfeasance by its committee appointees; pledges itself to prompt and fair inquiry into any such allegations delivered to it; and urges the University Faculty to refer Professor Brabner's motion to the Senate for such prompt and fair inquiry.
