- A. Recommendations from the Committee on Committees, H. Kingsbury, chairperson, for corrections in the charges and memberships of certain committees, to reflect recent changes in administrative titles and in the status of the College of Physical Education, Athletics and Recreation.
  - 1. RESOLVED, that the Faculty Senate Bylaws: III, Standing Committee System of the Faculty and its Senate: Undergraduate Admissions and Standing, is changed to read as follows (underlined words to be deleted; words in brackets to be added):

### UNDERGRADUATE ADMISSIONS AND STANDING, COMMITTEE ON

This committee shall recommend, for final determination by the faculty or its Senate, the undergraduate educational and academic admissions policies, and, in consultation with the Committee on Undergraduate Records and Certification, the policies of academic standing of undergraduates. The committee shall advise the <u>Directors of Admissions and Records</u>
[Dean of Admissions and the Director of Records] in implementing these policies. . . .

This committee shall consist of an appointee of the President; the Associate Provost for Instruction; the <u>Director</u> [Dean] of Admissions, as an ex officio, non-voting member; two undergraduate students; and a faculty member from each college enrolling undergraduate majors and the <u>Division</u> of <u>Physical Education</u>, Athletics and Recreation, one of whom shall be chairperson.

(Note: the charge to this committee as given above includes changes which were approved by the Senate on March 3, 1980, but which do not appear in the charge as it appears in the current Handbook, p. I-18.)

2. RESOLVED, that the Faculty Senate Bylaws: III,
Standing Committee System of the Faculty and
its Senate: Library Committee (Handbook p. I-18)
and Committee on Student and Faculty Honors (p. I-19)
are changed to read as follows (underlined words to
be deleted):

#### A. Library Committee

This shall consist of the Director of Libraries; one faculty from each of the several colleges and the Division of Physical Education, Athletics and Recreation, of whom one shall be chairman; one undergraduate student; and one graduate student. [no change in remainder]

## COMMITTEE ON STUDENT AND FACULTY HONORS

[no change in first paragraph]

It shall consist of one member from each college and the Division of Physical Education, Athletics and Recreation, including the Office of Graduate Studies, one of whom shall be chairperson; two undergraduate students and one graduate student; and an appointee of the President.

B. A recommendation from the Committee on Committees, H. Kingsbury, chairperson, to correct the wording of a committee membership so that it accurately reflects changes in the committee's structure which were approved by the Senate in September, 1978.

RESOLVED, that the Faculty Senate Bylaws: III, Standing Committee System of the Faculty and its Senate: Cultural Activities and Public Events, Committee on, paragraph 3 (Handbook p. I-20) is changed to read as follows (underlined words to be deleted; words in brackets to be added):

The Cultural Activities and Public Events Committee shall consist of: nine [seven] faculty members being a chairperson, the four [three] chairpersons of the subcommittees, and one faculty member from each subcommittee as elected by the several subcommittees; one appointment by the Provost; one appointment by the Vice President for Student Affairs; three undergraduate students; and one graduate student.
