The Music Minor in Musical Studies is for nonmusic majors who wish to increase their knowledge and understanding of the history and the theory of music. The following is a list of the course requirements:

No audition or musicality testing is required for admission into the minor in musical studies.

BACHELOR OF ARTS IN LANGUAGES

1. Purpose

The major in Languages is designed to provide students with a broad background in three or four languages and in introductory linguistics. Students participating in this program would be prepared for a career in a field requiring a knowledge of one or more foreign languages (e.g., airline flight attendant, travel agent), admittance to our program in simultaneous and consecutive interpretation or for graduate work in linguistics.

2. Description

The major in Languages requires at least 51 credits in language, literature and linguistics, with a minimum of 21 credits at the 300 and 400 levels. Course work in literature (written cultural documents) complements theoretical work in language (i.e., linguistics) and practical training in language skills up to and including the advanced level.

Two options are available. The first option offers the student training to a considerable depth in each of two languages and some familiarity with a third; the second option offers the student training to a considerable depth in one language, significant experience in two other languages and some familiarity with a fourth. Students desiring greater concentration in their language preparation would choose the first option, and those desiring skills in several languages would choose the second.

Faculty

The Department of Languages and Literature has a large faculty of qualified instructors. The program calls for no additional staff members.

5. Courses and Instructional Equipment

All the required courses are currently listed in the Course Catalog and are being offered. The Language Laboratory is fully equipped with tapes, slides, filmstrips and films for the students' needs. The Department has active computer-assisted instruction programs in several languages, including PLATO and PLATO-like lessons, in place and under development. Library holdings are more than adequate for this B.A. program.

6. Costs

No additional costs are forseen.

UNIVERSITY OF DELAWARE - COLLEGE OF NURSING PROPOSED ORGANIZATIONAL CHANGES

The faculty of the College of Nursing proposed that the academic units of the College be organized in two departments. The recommended change in organization is based on considerable study of the philosophy, goals, objectives of the College, and of the organization of other academic units in the University.

At present, the College is organized in two fields of study--undergraduate and graduate, and an office of continuing education, each with a designated coordinator (see Figure 1).

The organizational changes recommended and approved by the faculty are presented in Figure 2. The proposed program structure is presented in Figure 3. The changes are to be accomplished through reallocation of funds within the College budget. The Dean and faculty of the College of Nursing request that these changes be approved and become effective July 1, 1983.

RATIONALE FOR THE RECOMMENDED CHANGES

The College of Nursing offers two degree programs: 1) a bachelor of science in nursing (BSN) for students with no previous education in nursing and for registered nurses with a diploma or associate degree in nursing, and 2) a master of science (MS) degree for registered nurses who hold a BSN degree. The BSN degree program prepares the graduate for entry level practice as a generalist in nursing. The MS degree program prepares specialists in a particular field of nursing practice. At present, four areas of specialization are offered in the MS degree program: geriatric/gerontological nursing, maternal/child nursing, medical/surgical nursing, and psychiatric/mental health nursing. (In addition, the College of Nursing offers, in conjunction with the University Division of Continuing Education, a program of continuing professional education for nurses in the State and in the region). Because of the distinct differences in the goals of the two degree programs, we believe that the proposed structure will enhance program integrity, and effectiveness and efficiency in decision making. The proposed structure also will facilitate faculty accountability.


The proposed structure and the names of the departments, Department of Nursing Science and Department of Advanced Nursing Science, will emphasize the mission of the College of Nursing in the State and in the region. The names reflect the necessary scientific and research base for nursing practice and the concept of advanced preparation in nursing for practitioners in specialized fields of nursing. At the present time, the College of Nursing does not offer a doctoral degree, but a doctoral program in nursing is one of the long-range goals of the College.

For several years, the faculty has recognized the need to reorganize but major attention was focused on curriculum change in the undergraduate and graduate programs. Major changes in the BSN and MS programs have been initiated. The proposed organization will provide faculty with more autonomy in decision making about curriculum, management of fiscal resources, and faculty assignment, and will facilitate efficient operation of the College in a period of fiscal constraint. Departmentalization will also strengthen faculty peer review through introduction of an additional step in the appointment, reappointment, promotion, and tenure process.
