RESOLVED, that the University Faculty Senate approves and recommends to the Board of Trustees the following addition to the University Promotion Policy, to be added at the end of Section B: Minimum Standards for Promotion (page III-K-2 of the present Faculty Handbook):

University employees with professional contracts who also hold faculty appointments in academic units are eligible for promotion without tenure. Statements of the criteria for such promotions will be developed by academic units, subject to the same approvals as those required for criteria statements for the promotion of full-time faculty.

RESOLVED, that the University Faculty Senate approves and recommends to the Board of Trustees the following addition to the University Tenure Policy, to be added as a new section (c) under part 5 of Section L: Tenure (page III-L-1 of the present Faculty Handbook):

- (c) University employees with professional contracts who also hold faculty appointments in academic units are not eligible for tenure.
