C. Request for confirmation of an appointment to the Council on Program Evaluation (COPE).

RESOLVED, that the appointment of Professor Arthur Metzner, Department of Chemical Engineering, to replace Professor Jerold M. Schultz on the Council on Program Evaluation is hereby confirmed.

- D. Recommendation from the Committee on Committees (J. Morrison, chair) to establish a Subcommittee for Retiring, Retired, and Emeriti Faculty.
 - RESOLVED, that a Subcommittee for Retiring, Retired, and Emeriti Faculty is established as a permanent subcommittee of the Committee on Faculty Welfare and Privileges. This Subcommittee is charged with examining University policy and making recommendations with regard to the welfare and privileges of retiring, retired, and emeriti faculty, and shall report to and through the Committee on Faculty Welfare and Privileges to the Faculty Senate.

Members of the Subcommittee shall be selected by the Committee on Committees and shall be confirmed by the Faculty Senate. The Subcommittee shall consist of two tenured faculty members, one of whom is a member of the Committee on Faculty Welfare and Privileges, and two members who have retired from the faculty of the University. The Subcommittee shall select its own chair, but for convenience the chair of the Committee on Faculty Welfare and Privileges may designate one member as acting chair to call the first meeting of the Subcommittee each academic year. Members of the Subcommittee shall serve for two year terms; the Committee on Committees is empowered to adjust the initial terms of appointment so that one half of the subcommittee members are replaced each year.

E. Recommendation from the Committee to Regulate the Use of Beverage Alcohol (S. Hastings, past chair) to change the Faculty Senate Policy Concerning Use of Alcoholic Beverages.

RESOLVED, that Section II.c. of the Explanation of Regulation (page 1) of the Faculty Senate Policy Concerning the Use of Alcoholic Beverages is changed to read:

II.c. Newark City Code Chapter 22, Section 22-83(e) makes it unlawful to possess any open container containing intoxicating beverages where prohibited by the property owner. This applies regardless of age.

[Note: Section II.c. presently reads:

Newark City Code, Chapter 22, Section 22-83(3) makes it unlawful to consume intoxicating beverages where prohibited by the property owner. This applies regardless of age.]

M.A. in Foreign Languages

The degree proposed contains three options: a single-major plan almost identical to the present M.A.; a double-major plan; and a major-minor plan. The three options comprise a core curriculum of six credits plus 24, 36 and 30 credits in designated areas.

OPTIONS

Core Curriculum

Six credits as follows:

- 1. (3 credits) History OR Structure of Major Language (new course for some divisions)
- 2. (3 credits)
 - a. <u>Linguistics Option</u>
 ML 602 (Descriptive Linguistics) or
 ML 601 (Historical Linguistics) are recommended
 - b. Literature Option
 Methods of Teaching Literature (new course) or one course in
 Major literature

Note: ML 621 (methodology) is required of teaching assistants. Some programs may include this course in the minimum requirements.

Thesis Option

Up to six credits may be applied to work on a thesis.

Examinations

Major sections will be responsible for comprehensive examinations.

Specific Requirements in Major or Minor

Any special course requirements will be determined by the appropriate section. Note: Option I is almost identical to the present master's degree.

Current Major Fields

French, German, Spanish

Current Minor Fields

French, German, Spanish, Latin, Interpretation

Eventual Additional Fields

Italian, Russian; with cooperation from English Department, Comparative Literature and Linguistics could be serviced by this degree.
