WHEREAS no Senate approved policy specifically regarding the advisement of freshmen currently exists; and

WHEREAS the Executive Committee of the University Faculty Senate has been made aware of significant faculty concern regarding these issues in general and a recently suggested procedure (see Attachment 2 of this Agenda) for freshmen advisement in particular, therefore

BE IT RESOLVED

that each college, in consultation with its departments (where such exist) shall develop a set of written procedures which: (a) serve to guarantee meaningful contact between all freshmen students and their advisors, and (b) are then implemented by these units; and

BE IT FURTHER RESOLVED

that the form (though not necessarily the exact content) of each college's procedural statement be modelled after the "seven step" list presented in Attachment 2 of this Agenda.

Proposal for Advisement and Registration for 1983-84 for Freshmen

Advisement and Registration for Fall (84A)

1. New students will receive academic advisement before registration during the New Student Program.

Advisement and Advance Registration for Spring (84B)

- 1. Instructional letter will be sent by the college dean to all freshmen, class of '87. Letter will describe advisement and registration procedure.
- 2. Preprinted registration forms for freshmen will be sent to departments before the advance registration period.
- 3. Three-part advisement worksheet will be available in departments, one copy to be retained by advisor, one given to the student, one sent to dean's office.
- 4. Student makes appointment to see advisor.
- 5. After giving advice the advisor fills out the worksheet, including alternates, and signs it. Advisor retains copy of worksheet and gives the student his/her copy.
- 6. Student then is given his/her scan form; fills it out in accordance with the courses on the worksheet. Student returns the completed scan form to the advisor. The advisor signs and forwards the scan form to the registration officer.
- 7. Records Office processes registration form.
