The Graduate Committee unanimously approves the request from the College of Education to make the following changes in the names of two graduate majors:

1. Under the Master of Instruction degree, change the name of the major from "Instruction" to "Education."
2. Under the Master of Counseling degree, change the name of the major from "Counseling" to "Agency Counseling."

V. Old Business

A. A resolution introduced from the floor at the December 5, 1983 Faculty Senate meeting. (John Morgan, Senator, Physics Department.)

WHEREAS the University of Delaware has been experiencing a problem with an unacceptably high number of dismissals of freshmen for academic deficiency, and

WHEREAS most freshmen encounter difficulty in making the transition from high school courses to the more rigorous demands of university courses, and

WHEREAS it is very helpful for freshmen (and their advisors) to receive in mid-semester an unambiguous warning of inadequate progress in their courses so that they have ample time and opportunity to improve their performance, be it

RESOLVED that every freshman shall be assigned a meaningful mid-semester letter grade (A, B, C, D, or F) in each course in which he/she is enrolled for credit; furthermore, be it

RESOLVED that every freshman shall be assigned a mid-semester grade of P or F for each course in which he/she is enrolled in P/F status.

VI. New Business

A. A resolution from the Committee on Committees (M. Andersen, Committee Chair) regarding a change in the composition of the Faculty Senate Computer Committee.

WHEREAS the current composition of the Computer Committee includes a slot reserved for the Associate Provost for Computing; and

WHEREAS such a person does not exist in the current personnel of the University; and

WHEREAS it seems reasonable that this committee include representation by those administering major units of the University's computing services,

BE IT RESOLVED that the slot for the Associate Provost for Computing be redesignated to include the Director of Academic Computing Services, the Director of Management Information Systems, and the Director of Computer-Based Instruction.

(Note: approval of this resolution would lead to a change in the charge to this committee as indicated in Attachment 3.)

B. A joint resolution from the Committee on Student Life (C. Marler, Committee Chair) and the Committee on Academic Freedom (J. Magoon, Committee Chair) regarding the Freedom of Association section of the Student Guide to Policies. (Presented by C. Marler)

WHEREAS the current (1983-84) Student Guide to Policies contains a modification of the Freedom of Association statement suggested by a special committee of the Board of Trustees (see attachment 4a) and,

WHEREAS this current version has yet to receive required Faculty Senate consideration, and

WHEREAS after careful consideration of this statement, the Committees on Academic Freedom and Student Life have jointly developed an alternative which is judged preferable to the current (1983-84) version

BE IT RESOLVED that the Faculty Senate approve the abovementioned alternative so that the Freedom of Association section of the Student Guide to Policies reads as follows:

IV. STUDENT DEVELOPMENT

Freedom of Association

Section 1.

Students are free and encouraged to organize and join associations to promote their common interests. Registered student organizations may have affiliations with organizations, international, national, and/or regional, outside the University of Delaware and be subject to policies and requirements of the parent organization, provided that this relationship entails no conflict with the criteria specified in Part 2 below, or with the requirements of the remainder of this section. Student organizations petition the Delaware Undergraduate Student Congress for registration by filing an "Application for Registration." Registered student organizations may use University facilities designated by University policy for meetings and other programmed activities when the facilities are available and the events are properly planned and scheduled. Upon approval of the Delaware Undergraduate Student Congress and the Director of Student Life, organizations receive the status of being a registered student organization. Registered student organizations are subject to all existing University policies and regulations.

Section 2.

Policies and actions of a registered student organization are determined by a vote of only those persons who are members of the registered student organization. Membership in registered student organizations is limited to full time

undergraduate students, unless specific exceptions are approved by the Director of Student Life.

Every student organization must choose an adviser from the faculty, professional or staff members of the University. Advisers counsel organizations on the exercise of responsibility. Registration is not withheld or withdrawn solely because of the temporary inability of a student organization to get an adviser. Generally speaking, the selection of an adviser is the prerogative of the student organization. From the time when an organization completes the "intent to register" form, it is allowed thirty (30) days to fulfill the requirements for registration including obtaining an adviser. If an adviser resigns, a replacement must be found within thirty (30) days or the registration will be cancelled. The termination of the adviser relationship may be made by either the organization or the adviser.

For certain types of activities, and use of certain facilities and equipment, charges are assessed. In these instances, organizations receive advance notification of such charges. Organizations using University facilities and equipment will be charged for any damage to the facilities and/or equipment for which they were responsible.

No registered student organization is to be granted privileges denied to another or to be subjected to regulations not binding on another.

In rare circumstances, the University may deny registration to or withdraw previously approved registration from student groups which:

(a) Possess unlawful aims and goals; or

(b) Pose a substantial threat of material disruption such as interruption of classes, damage to the property of others, interference with the rights of others, exposure of students or others to an unreasonable risk of harm, or disruption of the regular and essential operation of the University; or

(c) Are unwilling to be bound by University rules and regulations governing conduct.

The registration status of a group may be suspended or revoked for violating the University's Code of Conduct. The procedures for enforcement suspension and other sanctions against registered student organizations are outlined in Section XIV and Section XVI in the Student Guide to Policies.

(Note: The original version of this statement (which appeared in the 1982-83 Student Guide to Policies) is reprinted in Attachment 4b. The current version and its proposed modification are

reprinted in Attachment 4c.)

FURTHER, BE IT RESOLVED that Article VI. of the Student Rights and Responsibilities section of the Student Guide to Policies be modified to read as follows:

(Note: Portions underlined represent additions; portions in parentheses represent deletions.)

VI. Conduct Expectations

It is the obligation of each member of the University community to act so as to give fullest respect to the views and activities of fellow members of the University community; to proceed in all actions with thoughtfulness and openness; and to treat every member of the University community in such a way as to acknowledge each person's humanity.

Student Conduct and Discipline

In developing responsible (student) conduct, disciplinary action plays a secondary role to example, counseling, guidance and admonition. The University community protects its educational purpose by setting standards of scholarship and conduct for its students and registered student organizations, and by regulating the use of the University facilities.

The administration of discipline guarantees procedural fairness to an accused student or registered student organization. Disciplinary proceedings may be instituted by any member of the University community only for violations of standards of conduct published in advance. In all situations, students or registered student organizations are informed of the charge against them and are given a fair opportunity to refute those charges. The Vice President for Student Affairs is responsible for the establishment of a student judicial system to adjudicate violations of the code of conduct. Students or registered student organizations charged with conduct violations within the Student Judicial System may also be charged in off-campus courts at the same time.

FURTHER, BE IT RESOLVED that the Board of Trustees be informed of the Faculty Senate's action on this issue

C. A resolution from the Committee on Undergraduate Studies (Daniel Callahan, Acting Chair) on the scheduling of exams outside of class.

WHEREAS undergraduate students are occasionally required to take examinations other than final examinations during times other than regular class or laboratory times for a course; and

WHEREAS such requirements have occasionally resulted in undergraduate students having unanticipated schedule conflicts which the students are incapable of resolving; and

WHEREAS the time period from 4:00-7:00 PM has been identified by the Records Office as the one which minimizes potential conflicts;

BE IT RESOLVED that exams other than final exams, which are to be given at other than the regularly scheduled class and laboratory times for a course must be scheduled during the 4:00-7:00 PM period Monday-Friday;

BE IT FURTHER RESOLVED that the days of the week and hours of any and all such exams must be included in the preliminary registration booklet and the exact dates and times for any and all such exams must be included in the revised (final) registration booklet.

D. Resolution from the Committee on Undergraduate Admissions and Standing (R. Dean Shippy, Chair) on a policy regarding the readmission to the undergraduate program of students who have withdrawn from the University.

WHEREAS college/department/program requirements for the degrees offered by the University of Delaware can and do change, and

WHEREAS such changes can lead to uncertainties as to the appropriate course of study for readmitted students

BE IT RESOLVED that the University Faculty Senate approves and recommends for inclusion in the Undergraduate Programs and Policies Catalog, the following:

All students readmitted to the University will be subject to the current requirements of the program and college in which they enroll. Exceptions to this policy may be made by the dean of the college.

Insofar as possible, prior course work will be accepted toward the degree. Course work which has been taken more than seven calendar years earlier will be reviewed for applicability. An individual department may require repetition of "outdated" prerequisite courses.

The College of Education requests that the major for the Master of Instruction degree, now shown as "Instruction", be changed to "Education"; and that the major for the Master of Counseling degree, now shown as "Counseling" be changed to "Agency Counseling". These proposed changes affect only the name of the major and have no effect whatever on program content or requirements.

The Committee on Graduate Studies unanimously approved the request at its meeting of December 6, 1983, and requests Senate approval.

COMPUTER COMMITTEE

This shall consist of (the Associate Provost of Computing,) the Director of Academic Computing Services, the Director of Management Information Systems, the Director of Computer-Based Instruction, seven faculty members of whom one shall be Chairperson; and one undergraduate and one graduate student. It shall advise on policies on the use and on the expansion of computer facilities, and hear and coordinate suggestions thereon.

SUBJECT: Student Rights and Responsibilities Statement

Last fall Mr. Bredin, Chairman of the Board of Trustees, appointed Mr. Veasey, Chairman of the Student Affairs Committee of the Board of Trustees, to chair a special Trustee Committee to Examine Student Organizations and Their Use of University Facilities. The Committee met with President Trabant on January 17 and again on April 12. It examined several issues concerning religious cults on the University campus. Vice President Sharkey assisted the Committee in this endeavor. As a result of the Committee's deliberations, changes in the Student Rights and Responsibilities Statement in the Student Guide to Policies were suggested. President Trabant has asked that these changes be sent to the Faculty Senate for consideration.

The attachment includes the current Student Rights and Responsibilities Statement and suggestions for change in Section IV, "Student Development". Two of the changes are substantive. In paragraph B, "registered student organizations are subject to all existing University policies and regulations", this change makes it clear that all student organizations must abide by University policy. In paragraph C, the underlined portion clarifies the student organization registration process more thoroughly than in the current statement. Attachment 4b: The 1982-83 version of the Freedom of Association statement in the Student Guide to Policies.

Note: The current version of this statement [which has yet to receive Senate consideration] appears in Attachment 4c. The version printed below can be compared with the current version by means of the lower case letters which label each sentence in both versions. The present attachment also indicates where entirely new sentences were inserted to produce the current version.

IV. Student Development

Freedom of Association

[a]Students are free to organize and join associations to promote their common interests. [b]Student organizations petition the Delaware Undergraduate Student Congress for registration by filing an "Application for Registration." [c]Upon approval of the Delaware Undergraduate Student Congress and the Office of Student Programs, organizations receive the status of being a registered student organization. [d,e]Registered student organizations may have an affiliation with organizations, national and/or regional, outside the University of Delaware and be subject to policies and requirements of a parent organization, provided that this relationship entails no conflict with University objectives, policies and activities. [f]The University reserves the right to deny registration to student groups whose major focus involves activities which expose their members to high bodily risk for which the University might be considered liable.

[g]Under the provisions defined above, membership, policies and actions of a registered student organization are all determined by a vote of only those persons who are members of the University community. [h]Membership in registered student organizations is limited to full-time undergraduate students, unless specific exceptions are authorized in the "Application for Registration." [i]Every student organization must choose an adviser from the faculty, professional, or staff members of the University. [k]Registration is not withheld or withdrawn solely because of the temporary inability of a student organization to get an adviser. [l]Generally speaking, the selection of an adviser is solely the prerogative of the student organization. [Note: SENTENCES m AND n OF THE CURRENT VERSION APPEAR ABOUT HERE.] [o]The termination of the advisory relationship may be made by either the organization or the adviser. [j]Advisers may counsel

organizations in the exercise of responsibility but they do not have the authority to control the policy of such organizations. [Note: THE FOLLOWING 2 SENTENCES DO NOT APPEAR IN THE CURRENT VERSION.] In a limited number of activities, such as student publications, professional societies, and campus radio station, advisers are appointed in accordance with stated University or organization requirements. This is reflective of the fact that for such organizations advisers may need to have special knowledge in the field.

[p]Registered student organizations may use University facilities designated by University officers for meetings and other programmed activities when the facilities are available and the events are properly planned and scheduled. [Note: IN THE CURRENT VERSION, sentence q appears about here.] [r]For certain types of activities, and use of certain facilities and equipment, charges are assessed. [s]In these instances organizations receive advance notification of the charges other than those to be made for unpredictable damages for which they were responsible. [u]No registered student organization is to be granted privileges denied to another or to be subjected to regulations not binding on another.

[Note: SENTENCE t OF THE CURRENT VERSION APPEARS ABOUT HERE.] [v]The registration status of a group may be rescinded by the Delaware Undergraduate Student Congress and the Office of Student Programs in accordance with procedures established for this purpose.

when an organization completes the "intent to register" form, it is allowed thirty (30) days to fulfill the requirements for registration including obtaining an adviser.

[n]If an adviser resigns, a replacement must be found within thirty (30) days or the registration will be cancelled.

[o]The termination of the adviser relationship may be made by either the organization or the adviser.

selection of an adviser is the prerogative of the student organization. [m]From the time when an organization completes the "intent to register" form, it is allowed thirty (30) days to fulfill the requirements for registration including obtaining an adviser. [n]If an adviser resigns, a replacement must be found within thirty (30) days or the registration will be cancelled. [o]The termination of the adviser relationship may be made either by the organization or the adviser.

[p]Registered student organizations may use University facilities designated by University policy for meetings and other programmed activities when the facilities are available and the events are properly planned and scheduled. [q]Organizations using University facilities and equipment will be charged for any damage to the facilities and/or equipment for which they were responsible. [r]For certain types of activities, and use of certain facilities and equipment, charges are assessed. [s]In these instances, organizations receive advance notification of such charges. [t]The University reserves the right to cancel or terminate any meetings or activities if the conduct planned for or being engaged in violates any policy of the University or is contrary to the criteria for registration specified in Paragraph 2 above.

[u]No registered student organization is to be granted privileges denied to another or to be subjected to regulations not binding on another.

[v]The registration status of a group may be rescinded by the Delaware Undergraduate Student Congress and the Office of Student Life in accordance with procedures established for this purpose.

[r]For certain types of activities, and use of certain facilities and equipment, charges are assessed. [s]In these instances, organizations receive advance notification of such charges. [q]Organizations using University facilities and equipment will be charged for any damage to the facilities and/or equipment for which they were responsible.

[u]No registered student organization is to be granted privileges denied to another or to be subjected to regulations not binding on another.

[f]In rare circumstances, the University may deny registration to or withdraw previously approved registration from student groups which:

(a) Possess unlawful aims and goals; or

(b) Pose a substantial threat of material disruption such as interruption of classes, damage to the property of others, interference with the rights of others, exposure of students or others to an unreasonable risk of harm, or disruption of the regular and essential operation of the University; or

(c) Are unwilling to be bound by University rules and regulations governing conduct.

[**]The registration status of a group may be suspended or revoked for violating the University's Code of Conduct. [**]The procedures for enforcement suspension and other sanctions against registered student organizations are outlined in Section XIV and Section XVI in the Student Guide to Policies.

Attachment 5: The policy statement to be modified by the proposal from the Committee on Undergraduate Admissions and Standing. It appears on pp. 15-16 of the 1983-84 Undergraduate Academic Programs and Policies Catalog.

READMISSION TO THE UNDERGRADUATE PROGRAM

An undergraduate student must file a formal application for readmission if the student: (a) was dropped by the University for unsatisfactory scholarship; (b) was a full-time student and officially or unofficially withdrew regardless of the reason, after registering for an academic term; (c) was separated for disciplinary reasons; (d) had a break in enrollment of one semester (excluding summer sessions) if a full-time degree candidate or of 15 months if a part-time degree candidate; or (e) has completed a degree program and desires to enroll in a new degree program or as a special student.

Students dropped by the University for unsatisfactory scholarship should consult with the dean of the college to which they seek readmission in order to ascertain their eligibility as well as to obtain the dean's approval for courses to be taken in the Division of Continuing Education or summer and winter sessions if these courses are to qualify the student for readmission. Students seeking to qualify for readmission may make application while course work in the summer school or Division of Continuing Education is in progress. Such students will be given a conditional readmission, contingent upon satisfactory reduction of the quality point deficit to 6 or less. Students qualifying for readmission will not be guaranteed admission to the program in which they matriculated.

A student seeking readmission may obtain an application for readmission from the Admissions Office. A fee of \$15 is charged for the processing of the application. The application for readmission must be submitted not later than July 1 for the fall semester and not later than December 1 for the spring semester.
