The College of Arts and Science Senate recently passed the following motion:

- RESOLVED, that all students taking a Bachelor's Degree in the College of Arts and Science should be required to satisfy the minimum mathematics requirement established for Bachelor of Arts candidates, and further be it
- RESOLVED, that all students taking a Bachelor's Degree in the College of Arts and Science should be required to satisfy the upper division writing requirement, and further be it
- RESOLVED, that all students in Bachelor's degree programs not covered by the requirements for Bachelor of Arts candidates should be offered as broad an exposure to the four subject matter groups of the general education program as the requirements of their specific programs will permit, with special emphasis on those subject matter groups outside their particular areas of specialization, and further be it
- RESOLVED, that these requirements be in effect for students entering in September, 1984, or as soon thereafter as it is possible for these new requirements to be contained in printed University catalogs. The intent of this resolution is to implement these resolutions at the earliest possible date but also to insure that this information is available to students prior to matriculation.

A question has been raised as to whether or not the curriculum change must also be approved by the University Senate. I would appreciate your advice and disposition of this matter. Please note that the implementation date is proposed as September 1, 1984.

CREDIT BY EXAMINATION

The University provides to all matriculated and Continuing Education students the opportunity to obtain college credit by examination for demonstrated competence attained through professional experience, independent study, or some similar learning experience, but not previous enrollment in a course. (Previous enrollment, in this instance, excludes official withdrawal during the official withdrawal period for the semester or session.) The credit by exam option is restricted to students who are either matriculated or currently enrolled. General inquiries concerning credit by examination should be directed to the department offering the course for which the student seeks credit. A credit-by-examination form available at the Records Office must be completed following the instructions on the form.

Note: Changes in policy are underlined.
