# CHANGES IN B.A.L.S. DEGREE AND PROGRAM REQUIREMENTS COLLEGE OF ARTS AND SCIENCE

(Passed A&S Senate March 18, 1985)

#### OLD

Foreign language recommended but not required.

Minimum grade average at time of application is 2.00.

Student must complete 45 credits after beginning the program.

Full-time faculty member agrees to be advisor prior to program submission.

#### NEW

Foreign language requirement same as for B.A. curricula.

Minimum grade average at time of application is 2.00.

Application deadline: end of first semester of junior year or before completion of 75 credits.

Full-time faculty advisor (with pertinent specialization) and secondary advisor write letters of recommendation about the proposal, at time of application.

Primary advisor makes annual report on student's progress, etc.

Student must devote at least 39 credits to the B.A.L.S. program courses over and above general education and language requirements.

# (Proposed Requirements) BACHELOR OF ARTS IN LIBERAL STUDIES

## PURPOSE AND DESCRIPTION OF PROGRAM

The Bachelor of Arts in Liberal Studies (BALS) degree provides the opportunity for students to plan and pursue broader interdisciplinary programs than the normal major and minor, double major, or interdisciplinary major allows. The program is designed for students who have need and justification for developing their own undergraduate program within the 124-credit minimum. Instead of pursuing a major in one of the existing degree options of the College, a student in the BALS program will take a sequence of courses consistent with his/her stated educational goal and which will afford the student knowledge in some broad, interdisciplinary field.

The BALS is, as the name suggests, a Bachelor of Arts degree for broad, in-depth studies of some combination of academic subjects. The program may be used to increase the breadth of one's studies in the arts, humanities, social sciences and sciences over what would be possible with a traditional major and electives. Emphasis should be placed on a general, well-rounded program of creative exploration even if the principal objective is to structure one's curriculum in terms of a particular career.

It is the intention of the University that a student graduating with a BALS degree should be well educated, capable of pursuing advanced studies in a graduate school of his or her choice, or capable of satisfactorily purusing a career.

Since the degree is available only to students in the College of Arts and Science, the proposed program must focus on a subject or subjects central to the liberal arts, e.g., language, science, philosophy, history, etc., which compose the curriculum of the College of Arts and Science, as distinguished from a technical or purely professional education. Normally,

no more than 15 credit hours may be taken in any one College other than

Arts and Science, and at least one half the total 124 credits for gradua
tion should be taken in the College of Arts and Science.

Admission into the Bachelor of Arts in Liberal Studies program is determined by a screening committee of the College Faculty Senate. The committee reviews student proposals, approving those that are cohesive and realistic, with the educational goal of the program clearly defined and carefully explained. The proposals must be two to four typed pages.

Advisement and planning are very important in formulating such a proposal. Students are urged to seek advice from faculty members and the Dean's Office as they work on their programs. The successful student proposal must be accompanied by letters of recommendation from the primary adviser and a second faculty member, addressing the significance and necessity of the program and the student's abilty to carry it out.

While it is impossible to enumerate the variety of programs which will be acceptable, proposals will be judged on whether they are:

- ◆ COHERENT the proposed courses and academic activities must be logically related.
- WELL-FOCUSED the proposal and its purpose should be clearly articulated. The central subject or area of study should be discussed and related to the various supporting academic fields.
- NECESSARY the proposal should indicate why the flexibility of the BALS program is necessary and why the proposed program could not be accomplished with existing major, interdepartmental of double major options.
- CONSISTENT the proposal should conform to the BALS degree requirements listed below.

#### REQUIREMENTS

▶ E 110, Exemption from this requirement is permitted to those who achieve a score of 650 or higher on the English Composition Achievement Test of the SAT (note: this is not the SAT verbal).

- Second Writing Course, chosen from an approved list. This course may also be one used for fulfilling other requirements, but must be taken in the junior or senior year.
- M 114 or M 115 or passing a proficiency exam.
- The general education area requirements for the B.A. degree, including a foreign language.
- A minimum of 124 credits, with at least 60 of those credits at or above the 300 level.
- A student must apply for the BALS degree by the end of the first semester of the junior year, or before the completion of 75 credits.
- A minimum of 39 credits must be devoted to the student's BALS project.
- Any changes in the program must be approved by the primary adviser and the Dean's Office.

A departmental major is not required.

In the BALS program, normally, no more than 15 credit hours may be taken in any one College other than Arts and Science, and at least one half the total 124 credits for graduation should be taken in the College of Arts and Science.

#### ELIGIBILITY

To be eligible, students must be matriculated, registered in the College of Arts and Science, and in good academic standing (2.45 grade point average or better) at the time of application.

#### ADVISEMENT

An integral part of any BALS program is conscientious, effective and continuous advisement. It is imperative, therefore, that students work closely with faculty advisers. A student must obtain the agreement of a full-time faculty member--whose area of specialization includes the proposed area of study--to be the student's primary adviser. The primary adviser and a second faculty member, whose academic specialization pertains to another area in the student's BALS program, must submit letters of recommendation specifically addressing the focus of the proposal, the necessity

for the proposed program, and the student's ability to complete it successfully. The primary adviser will be responsible for a brief annual report indicating the student's progress, listing the courses taken, and explaining any deviations from the original proposal.

#### PRODECURE FOR APPLYING TO THE PROGRAM

- 1. Discuss with the Dean's Office staff your general interest in the program.
- 2. Develop an initial draft of your written proposal.
- 3. Choose two faculty members, one to act as your primary adviser. Discuss with them your interests and share with them the initial draft.
- 4. Develop a final draft of your written proposal with your advisers.
- 5. Request that your two advisers write letters of recommendation, justifying the content of your proposal.
- 6. Submit your program proposal, together with the forms attached to this description, to the Dean's Office, 127 Memorial Hall no later than March 15 or October 15.
- 7. Your proposal will be evaluated by the Committee on Special Academic Programs of the Arts and Science College Senate. This Committee is responsible for the BALS program and appoints all candidates.
- 8. The Committee will approve or disapprove your program, and the Dean's Office will communicate the Committee's decision to you in writing before the end of the pre-registration period. The Committee may provisionally accept the proposal, based on your agreement to incorporate various changes.

#### LEAVING THE BALS PROGRAM -

If a student wishes to transfer out of the BALS program into another baccalaureate program, a change of major/college form must be processed.

The student must satisfy all the requirements of the program entered.

#### BALS PROGRAM

There are four differences between the present and proposed requirements. If the proposal is approved, the foreign language requirement will apply to BALS students; each applicant's advisor and a second faculty member will be required to write a recommendation as part of the application process; the advisor will be required to approve changes in the student's program and submit an annual report on the student's progress; students will be required to apply for the BALS program by the end of the first semester of the junior year or before completing 75 credits, and students will be required to devote at least 39 credits to the BALS program.

# PRESENT REQUIREMENTS (effective 83B)

## BACHELOR OF ARTS IN LIBERAL STUDIES

#### REQUIREMENTS

The Bachelor of Arts in Liberal Studies degree is to be awarded to students who complete an approved independently structured program of study.

Students admitted to the program must fulfill the following requirements:

- E 110, Exemption from this requirement is permitted to students who achieve a score of 650 or higher on the English Composition Achievement Test of the SAT (note: this is not the SAT Verbal)
- Second Writing Course, chosen from an approved list. This
  course may also be one used for fulfilling other requirements,
  but must be taken in the junior or senior year
- M 114 or M 115 or passing a proficiency exam
- The general education breadth requirements for the B.A. degree
- A minimum of 124 credits, with at least 60 of those credits at or above the 300 level
- Complete 45 credits after admission to the BALS candidacy

A departmental major is not required.

The foreign language requirement is recommended, but not required unless it is essential to the integrity of the program proposed.

Normally, no more than 15 credit hours may be taken in any one College other than Arts and Science, and at least one half the total 124 credits for graduation should be taken in the College of Arts and Science.

Any subsequent changes to the program approved at the time of admission to BALS candidacy must be cleared in advance by the Dean's Office. A major change of emphasis will require resubmission of the program for consideration according to the same procedures as followed for the original proposal.

#### ELIGIBILITY

To be eligible, students must be matriculated, registered in the College of Arts and Science, and in good academic standing (2.0 grade point average or better) at the time of application.

#### PURPOSE AND DESCRIPTION OF THE PROGRAM

The BALS degree has been established as an option to permit students to plan and pursue undergraduate programs of their own design which are compatible with both their interests and the educational goals of the University, but which are not necessaryly compatible with the requirements of other baccaluareate programs. Students are expected to submit a detailed written proposal (2-4 typed pages) describing the anticipated course of study and the reasons why the program is appropriate. While it is impossible to enumerate the variety of programs which will be acceptable, programs will be judged on whether they are:

- COHERENT the proposed courses and academic activities must be logically related.
- WELL-FOCUSED the proposal should be clearly articulated and its purpose understandable. There should be a central theme or area of study indicated, and its relationship to other academic areas should be described.
- APPROPRIATE the proposal should indicate why the flexibility of the BALS program is necessary and why the proposed program could not be accomplished with existing major, interdepartmental or double major options.
- CONSISTENT with the BALS degree requirements indicated on the first page above.

Students should be cautioned that the BALS degree is not to be used as a means for the avoidance of requirements in other programs. For instance, it should not be used to complete an essentially identical program in a major which restricts the entry of internal transfers, such as Communication, Allied Health Sciences, Computer Science or Business. It should also not be seen as a means for the avoidance of the foreign language requirement.

#### ADVISEMENT

An integral part of any BALS program is conscientious, effective and continuous advisement. It is assumed, therefore, that students will work closely with a faculty advisor throughout their academic program.

Prior to the submission of a program proposal, a student must obtain the agreement of a full-time faculty member to be the student's advisor. The advisor should be an individual whose interests are associated with the area of study proposed by the student.

## PROCEDURE FOR APPLYING TO THE PROGRAM

Students should consider taking the following steps:

- 1. Discuss with the Dean's Office staff your general interest in the program.
- Develop an initial draft of your written proposal.
- 3. Discuss with one or more faculty your interests and share with them the initial draft.
- 4. Choose a faculty member and obtain his or her formal agreement to act as your advisor.
- 5. Develop a final draft of your written proposal with your advisor.
- 6. Submit your program proposal, together with the forms attached to this description, to the Dean's Office, 127 Memorial Hall, no later than March 15 or October 15.
- 7. Your proposal will be evaluated by the Committee on Special Academic Programs of the Arts and Science College Senate. This Committee is responsible for the BALS program and appoints all candidates.
- 8. The Committee will approve or disapprove your program, and the Dean's Office will communicate the Committee's decision to you in writing before the end of the pre-registration period. The Committee may provisionally accept a proposal, based on your agreement to incorporate various changes.
- 9. If your proposal is not initially accepted, it may be resubmitted, according to the procedures described above.

#### LEAVING THE BALS PROGRAM

If a student wishes to transfer out of the BALS program into another baccaluareate program, a change of major/college form must be processed. The student must satisfy all the requirements of the program entered.

#### DEPARTMENTAL CONCENTRATION REQUIREMENTS

A concentration requirement is defined as nine credits beyond the introductory level in one department or six credits in each of two departments within the same group: i.e., humanities and arts, history and social science, or natural science and mathemetics. All courses counted toward the concentration must be of "C" grade or better.

#### ELECTIVE CREDITS

Sufficient elective hours are required to meet the minimum total of 60 credit hours. No more than six credits of EDO courses in shorthand and typing may be applied to an Arts and Science degree.

No courses numbered below the 100 level may be counted toward a degree from the College of Arts and Sciences.

- \*There is a foreign language proficiency requirement for all Bachelor of Arts degrees and for some Bachelor of Science degrees. For the baccalaureate degree which requires proficiency in a foreign language, ancient or modern, proficiency may be demonstrated by one of the following:
  - A. Completing four years of high school study of one language or two years of each of two languages with an average grade of "C" or better in each language.
  - B. Achieving scores on the language placement tests that indicate intermediate level proficiency.
  - (e.g., FR 112. GER 112, SP 112, LAT 112).
