V. Old Business

A. Recommendation from the Committee on Undergraduate Studies (M. Keefe, Chairperson), with the concurrence of the Coordinating Committee on Education (K. Lomax, Chairperson), for generic requirements for a minor and a concentration within a major to apply to all undergraduate degrees. This is in response to a resolution from former Senator S. Sandler at the May 13, 1991 Faculty Senate meeting.

WHEREAS, a minor represents a certain breadth of knowledge, and that knowledge should be somewhat distinct from that which forms the basis for the student's major, and

WHEREAS, there should be a clear distinction between a concentration in a major and a minor, therefore be it

RESOLVED, that a majority of the credits that a student uses towards fulfilling the requirements of a minor must be taken outside the primary subject area courses used to fulfill the requirements of the major.

(The four letter codes used for the various subject areas are listed in the Undergraduate Catalog.)

VI. New Business

RESOLVED, that the Faculty Senate approves provisionally, for four years, the establishment of a new major in Environmental Soil Science, leading to a B.S. in Agriculture (Department of Plant and Soil Sciences), effective immediately.



RECOMMENDATIONS TO PROVOST PIPES

Whereas the University Faculty Senate recognizes the need for increased incentives and broadly based support for scholarship, research, and creativity.

The Senate endorses and urges action on the Senate Research Committee's recommendations for research and graduate studies, as set forth in their 11/25/91 memo to you.

SUBJECT: Recommendations for Research and Graduate Studies

The Senate Committee on Research appreciated the opportunity to meet with you and Associate Provost Margaret Andersen on November 7, 1991. Your information on budget planning and its effect on research and academic programs was very helpful, and we were most interested to hear your ideas on the future of research at the university.

After further consideration of the issues raised in that meeting, the committee would like to recommend the following actions to improve the campus environment for research:

- 1. Funding for the General University Research (GUR) program has not kept pace with the need for seed money support of research in the social sciences, arts, and humanities. We would like to see a significant increase in GUR, and we recommend a request to the Unidel Foundation as one means of augmenting this program.
- We were pleased to hear that you will appoint a special committee to establish a graduate program development plan for the university, as recommended in the report of the Project Vision Implementation Committee. Because the work of the special committee could have significant implications for research, scholarship, and graduate education in the coming years, we urge that the group comprise a strong representation of faculty who have been recognized for their excellence in research and creativity.

- While the Research Committee accepts the challenge to increase external funding for research, we hope a comparable effort will be made in the area of development. Unless a careful balance is maintained between faculty efforts and development activities, those in disciplines with limited opportunities for outside support will be unfairly impoverished to the detriment of the institution.
- 4. So that faculty may be informed about development activities, we recommend formation of a committee of faculty to serve as a liaison between the faculty and the Development Office.
- 5. We recommend reinstatement of the Center for Advanced Study at the earliest possible date. Its symbolic value is important as visible evidence of the university's commitment to excellence in scholarship.
- 6. In addition to reinstatement of the Center for Advanced Study we propose establishment of a similar program for junior faculty, which, like the Presidential Faculty Fellows program on the national level, would be a stimulus for research.
- 7. The Committee on Research recommends that the university seek other new ways of rewarding excellence in research and creativity. Grants like GUR and UDRF reward proposed research; a means of recognizing the most outstanding products of research is also needed.
- 8. We request that the Committee on Research be included in the process to appoint the new vice provost for research and graduate studies.
- 9. We recommend that tuition rates for out-of-state graduate students closely approximate in-state tuition rates. This change would make us more competitive in attracting the best graduate students for our programs and would be especially helpful in disciplines where outside funding is limited.

The Committee on Research is not insensitive to the serious financial constraints that now affect university budget planning. At the same time, we believe that university support for research initiatives and recognition of outstanding products of research and creativity have been underfunded for quite some time. In our view, nothing is more important in maintaining the integrity and morale of the university community than encouragement of research and creativity.

Thank you for the opportunity to exchange ideas with you on research administration at the university. We will be happy to provide more information on any of the above recommendations at your request.
