Motion to Postpone Reapportionment of Senate

The University Faculty Senate hereby instructs the Committee on Rules to postpone until February 1, 1997 the recomputation of faculty memberships in the Senate as required by the Constitution of the Faculty of the University of Delaware, Section IV, paragraph 4., of the Faculty Handbook,

The Senate or a committee that it designates shall be responsible every second year for recomputing the formula for faculty senators. . . and shall notify each Unit by February 1 of that year of the number of faculty senators it is to elect in each of the following two years.

and as detailed in the Bylaws and Regulations of the University Faculty Senate on page I-7, paragraph J.1. which reads:

By February 1 of each year, the Secretary of the Senate shall inform the Units of the Senate of (1) the names of senators whose terms will expire during the current academic year, and (2) any changes in apportionment every other year, as stated in the Constitution. . . .
