# THE BACHELOR OF ARTS DEGREE

The degree of Bachelor of Arts is awarded to those students who follow a broad course of study designed to provide a liberal education. For this degree a student must complete a minimum of 124 credits including general University requirements, group requirements, and concentration requirements.

Students must meet the general University requirements given under Academic Regulations in the undergraduate catalog.

Students must complete the indicated number of credits in each of the following groups. These group requirements may be satisfied with courses offered by the departments listed below and with approved courses offered by the Colleges of Agricultural Science, Business and Economics, Education, Engineering, Home Economics, and Nursing, and the Divisions of Health Sciences and Physical Education. The College of Arts and Science shall approve and determine the courses which satisfy group requirements.

- GROUP I. Humanities and Arts (15 credits with at least 6 credits from one department and at least 3 from each of two others): Art, Art History, History or Appreciation of Drama or Music, English, Languages and Literature, Philosophy (except Logic). (No more than 6 credits of the foreign language proficiency requirement may be used to fulfill Group I requirements.)
- GROUP II. History and Social Science (15 credits with at least 6 credits from one department and at least 3 from each of two others):
  Anthropology (social and cultural), Black Studies, Economics, Geography (social), History, Political Science, Psychology (social), Sociology, Speech-Communication.
- GROUP III. Natural Science and Mathematics (14 or 15 credits in at least two departments): Astronomy, Anthropology (Physical), Biological Sciences, Chemistry, Geography (Physical and meteorology), Geology, Mathematics, Philosophy (Logic), Physics, Physical Science, Psychology (physiological), Statistics and Computer Science.

To meet the concentration requirements, students may elect a departmental major, a double major, an interdepartmental major, or an area study.

Departmental Major: Requirements for the departmental major are set by the department.

A special meeting of the University Faculty Senate was called to order at 4:05 PM. Senators not in attendance were:

Mr. Bonner suggested a routine for facilitating a full discussion of the committee report. The debate would be initially limited to Senators; since the committee report comes in the form of a motion to adopt, substantial changes or substitutions would be out of order until the motion to adopt is decided. If the motion to adopt is defeated, substantial changes would then be in order. Minor changes, editorial changes, etc., would be accepted prior to the vote on full adoption. However, during the discussion on whether or not to adopt, the content of possible amendments could be given as reasons for voting against full adoption.

Mr. Salsbury, Chairman of Committee on Undergraduate Studies, reported that the committee spent a considerable amount of time with the proposal. The request for the BA degree requirement changes came from the College of Arts and Science, to the Senate, through his committee; the committee was asked to consider it and report their findings. Many questions came from outside Arts and Science; therefore, hearings were held October 7 to discuss the changes. Approximately 80 to 90 people attended the hearings. Support for all of the recommendations was unanimous in the committee; no provision in the committee report substantially changed or added to the documents presented to the University Senate committee by the Arts and Science Senate.

The following minor changes or additions were, however, included in the committee report:

- 1. An implementation date of the first graduation following adoption was established.
- A statement indicating that courses offered by other colleges may be approved by the College of Arts & Science to meet group requirements.
- 3. The phrase "two years each of two languages" was added to clarify option "a" under proficiency in foreign language.
- 4. The double major had been overlooked in the draft of the C.A.S. document; it was put back in the committee report.

- <u>Double Major:</u> Students may complete all requirements for two departmental majors at the same time.
- Interdepartmental Major: An interdepartmental major may be elected upon consultation with the department chairmen concerned.
- Area Study: Opportunity is provided for students interested in pursuing a broader field of study such as American Studies and International Relations.

Proficiency in a foreign language (ancient or modern) is required. This proficiency may be demonstrated by one of the following:

- (a) Completing four years of high school study of one language or two years of study of each of two languages with an average grade of C or better.
- (b) Achieving scores on the language placement tests which indicate intermediate level proficiency.
- (c) Passing the appropriate intermediate language course.

Students may meet any requirement by demonstrating proficiency following the accepted practice of Credit Without Formal Course Registration.

Students may be awarded the Bachelor of Arts degree as described above at the first graduation following the adoption of these requirements by the University Faculty Senate.

THE BACHELOR OF ARTS IN LIBERAL STUDIES DEGREE

The Bachelor of Arts in Liberal Studies degree is awarded to students who complete an approved independently structured program of studies. A student must satisfy the general University requirements and meet the group requirements for the Bachelor of Arts degree except that a student may omit up to nine credits from the group requirements.

Proficiency in a foreign language is recommended but not required.

A minimum of 124 credits is required, and at least 60 credits must be earned at or above the 300 course level.

Students may be awarded the Bachelor of Arts in Liberal Studies degree at the first graduation following the adoption of these requirements by the University Faculty Senate.

Suggestions for minor changes were made from the floor. They included:

- 1. Inclusion of Marine Studies in Paragraph 3.
- 2. Omitted in Paragraph 3 "Students must also complete..."
- 3. Omitted from the section on Departmental Major:

"Requirements for the departmental major are set by the department. A minimum of 30 credit hours in courses counted toward the major. All courses counted toward the major must be of 'C' grade or better."

Not hearing further editorial changes, etc., Mr. Bonner requested of those persons who have amendments of substance that they indicate the content of their amendment as information of intent. The declarations of intent included:

- Mr. Harlan: Amend "Bachelor of Arts in Liberal Studies" to read "Bachelor of General Studies."
- Mr. King: Amend Group I to include Practical Music.
- Mr. Keesey: An interdepartmental major may be elected upon approval from the departmental chairman concerned and the Dean of the College. Appropriate forms for planning the interdepartmental program are available in the Office of the Dean.
- Ms. DeArmond: Propose that Art be dropped from first group. Propose that Language requirement be moved from first group and put in specific requirements. Propose that degree BALS be changed to BGS.
- Mr. Geiger: Amend to include 6 credits in Foreign Languages to Group I.
- Mr. Krum: Indicated his desire to see an amendment such that a student seeking a degree in liberal studies could not take an unlimited number of courses outside his own college.

Mr. Salsbury suggested that the proposed amendments be sent to his committee immediately. None of them appeared to violate the intent of his committee's document. If possible, his committee may revise their report to include the sense of the amendments.

The Senate requested Mr. Salsbury's committee to consider the suggested amendments and report their findings at a special meeting of the Senate to

conclude deliberations on this matter. The motion to fully adopt is still on the floor of the Senate. The special meeting will be November 8 at 4 PM.

Attached is a revised draft of the committee report. Revisions reflect the action taken by the Senate at the October 25 meeting.

The special meeting was adjourned at 5:25 PM.
