

RECESSED MEETING OF THE UNIVERSITY FACULTY SENATE

May 23, 1974

The recessed meeting of the University Faculty Senate was called to order at 2:05 PM. Senators not in attendance were:

The report and recommendations on the tenure policy from the Committee on Promotions and Tenure was discussed at the recessed meeting of May 13, 1974, with a motion being approved for a referendum of the faculty, and to provide the faculty with the tenure-policy recommendations. Professor Mosberg announced the results of that referendum: 261 responses (32% of the voting faculty); 175 voiced approval and 86 voiced disapproval. The comments will be categorized and distributed to the faculty.

Professor Raymond F. Goodrich proposed the following motion as a substitute for the entire tenure policy recommendation introduced by the Committee on Promotions and Tenure:

"On being retained past a period of seven years no full-time member of the teaching faculty will be dismissed except that it be demonstrated that the faculty member's retention would be disruptive of the educational and scholarly functions of his or her department."

The motion was seconded. A call for quorum count was made; lacking a quorum, no action could be taken by the Senate.

The Committee on International Studies had proposed a resolution for action by the Senate concerning a ruling by the United States Immigration and Naturalization Service prohibiting off-campus summer employment by foreign students in the United States without direct approval of the Immigration and Naturalization Service. Lacking a quorum, no action could be taken but it was requested to obtain the "sense" of the Senate with the stipulation that

the motion would be sent as such. An editorial change was made to the resolution deleting "summer employment opportunities" and replacing with "training opportunities derived from and during summer employment." The motion carried as a "sense" of the Senate. Professor Nosberg will send a letter with copies of the resolution to those indicated in the resolution. (Resolution attached.)

The meeting adjourned at 2:20 PM. The next meeting of the Senate will be in September.

Dear

It is the sense of the University Faculty Senate of the University of Delaware that the following resolution be forwarded to you:

"WHEREAS a ruling of April 19, 1974, by the United States Immigration and Naturalization Service prohibits off-campus summer employment by foreign students in the United States without direct approval of the Immigration and Naturalization Service; and

"WHEREAS this ruling severely restricts summer employment opportunities for foreign students (who in the summer of 1973 accounted for only 30,000 of a work force of 80 million) and thereby jeopardizes the educational opportunities of many of them; and

"WHEREAS this ruling could bring retaliatory measures from foreign governments against American students studying abroad-- the elimination, for example, of their eligibility for financial aid and for equal tuition rates; Therefore be it

"RESOLVED, that the Faculty Senate of the University of Delaware deplores the curtailment of those training opportunities derived from and during summer employment enabling many foreign students to continue their education in this Country and urges that our Government, recognizing the cultural benefits of young foreigners studying in the United States, attempt to aid rather than to impede present student exchange programs."
