

SPECIAL MEETING OF THE UNIVERSITY FACULTY SENATE

May 12, 1975

MINUTES

The special meeting of the University Faculty Senate was called to order at 4 PM. Senators not in attendance were:

Prof. T. E. D. Braun announced that Prof. L. Mosberg would be the Parliamentarian for the coming year.

Prof. Catts forewarned the Senate that another special meeting would be called shortly to discuss and act upon any recommendations to be made to the Board of Trustees concerning the revision of the student judicial system.

The purpose of this special meeting was to discuss the impact on the University community of the tuition increase as approved by the Executive Committee of the Board of Trustees. The tuition and fee schedule as approved and to become effective September, 1975 is:

	<u>Resident</u>	<u>Non-Resident</u>
Undergraduate	\$795	\$1,930
Graduate	795	1,930
U/G part-time (per credit hour)	34	81
Grad. part-time (per credit hour)	45	108

The billing policies approved and effective September, 1975 are:

- 0 - 11 credit hours - on a credit hour basis.
- 12 - 15 credit hours - full fee basis.
- 15+ credit hours - regular full fee, plus one-half the established credit hour rate for all credits in excess of 15.

Prof. R. Goodrich had initiated the call for a special meeting and was called upon to make an opening statement. He presented his views and introduced the following motion:

WHEREAS the worth of the educational programs of the University of Delaware depend ultimately on the excellence of our graduates and

WHEREAS the proposed tuition fee schedule places a surcharge on excellence and, in fact, on the completion of graduation requirements,

We the Senate of the University of Delaware respectively request that the new fee schedule be withdrawn and the administration, faculty and students jointly work out a necessary revenue scheme which will not penalize excellence.

The motion was seconded. Following discussion of the motion, Prof. Sharnoff made a motion to add the following to Prof. Goodrich's motion: "...in future revision of the tuition structure." The motion failed.

Following further debate, Prof. Goodrich's proposal was reread. A roll-call vote was requested, results being 25 for, 13 against, with one abstention. Motion carried. (Roll-call vote attached.)

Prof. Goodrich made the following motion:

That the results of the appropriate curricula-approving committee of the colleges and the University be suspended relative to the deadline for course numbering changes and that they consider all changes for the fall semester submitted to them by July 1 so that these changes may be consummated by the fall semester.

The motion was seconded. Following a lengthy discussion, a call for question was made. The motion was defeated.

The meeting adjourned at 5:15 PM.
