WHEREAS, the University of Delaware prioritizes high quality, affordable education

providing “broad access to a comprehensive array of educational programs that reflect high academic standards,” as a key to continuing academic progress and the construction program expands educational program offerings, and

WHEREAS, the University strives to “provide undergraduate education that ranks among the finest provided by any public university in America” and the construction curriculum has been developed following the best practices of top universities and tailored to the strengths of the faculty, and

WHEREAS, academic priorities for undergraduate education focus strive to “remain the institution of choice in the mid-Atlantic region” and the construction program, when accredited, will be the only such program in the Mid-Atlantic and Northeastern states, and

WHEREAS, there is strong industry support for establishment of the program which serves the needs and interests of the professional community and the program will substantially benefit the reputation of the University of Delaware in construction education, and

WHEREAS, the majority of courses in the program are not required until the junior year giving ample time for new course preparation and program marketing, be it therefore

RESOLVED, that the Faculty Senate approves provisionally, for five years, the establishment of a new major leading to the Bachelor of Construction Engineering and Management (BCEM) degree, effective September 1, 2017

WHEREAS, the Department of Medical Laboratory Sciences (MLS) in the College of Health Sciences has offered a successful program for the BS in Medical Laboratory Sciences offering students skills and knowledge necessary for careers in the profession of clinical laboratory science, and

WHEREAS, Workforce demands support the need for training programs aimed at generating a cadre of highly skilled laboratory professionals, with a defined skills set common to a wide variety of biotechnology sectors the program will employ a locked-step curriculum, the program, emphasize hands-on training and practical experience, while providing a solid foundation in the basic subjects from which biotechnology evolved, and

WHEREAS, MLS has received many inquiries over the last several years from individuals who are interested in pursuing careers in the biotech industry, and

WHEREAS, MLS has proposed Biotechnology and Applied Molecular Biology major, which will offer a route for students to pursue careers with specialized skills needed in areas of the biotechnology sector, such as Flow-Cytometry, Protein Purification and Characterization, Cell and Tissue Culture Techniques, Recombinant DNA & Protein Technologies, Molecular Diagnostics, Regulatory Affairs, QC & QA, etc., and

WHEREAS, Graduates will be uniquely positioned to begin laboratory careers in biotechnology R&D, molecular diagnostics, academic research, the pharmaceutical industry, public health, forensics, agri-biotech, and

WHEREAS, the existing undergraduate program in Medical Laboratory Sciences already provides foundational coursework, laboratory teaching and administrative framework for such a degree, and

WHEREAS, the program has received the full support of faculty as well as the faculty in all programs affected by the curriculum, and

WHEREAS, the proposed major contributes to one of the milestones on the University's "path to prominence" to achieve excellence in professional education; be it therefore

RESOLVED, that the Faculty Senate recommends provisionally for five years the approval of the establishment of a new Bachelor of Science in Applied Molecular Biology and Biotechnology.

WHEREAS, the University of Delaware has a university-wide policy that enables students to move more freely among majors and colleges. This policy provides students with the flexibility to pursue multiple majors and minors, to work at the interfaces between established disciplines, and to experience a broader selection of electives, and

WHEREAS, the University of Delaware has made a commitment to Undergraduate Students' success with new initiatives like the Blue Hen Success Collaborative, a revised First Year Seminar and other examples, and

WHEREAS, students who enter the University as University Studies majors must declare a major in order to graduate and other students choose to change majors during their academic careers and

WHEREAS, if those students have had difficulties in adapting to the more rigorous requirements of college courses and these difficulties have resulted in grade point averages below 2.0, by current University Policy, they can not declare majors or transfer majors until their GPA is at or above 2.0. This inability to transfer into their major of choice can result in inadequate academic advising (because they are still in their current department) and an inability to enroll in courses that may be restricted to students in a declared major. They are essentially "stuck without a good home," be it therefore

RESOLVED, that the Faculty Senate Committee on Undergraduate Studies, with the support of the Registrar's Office, asks that the current policy be changed to remove the 2.0 minimum GPA requirement for entry to Unrestricted majors. Policies set by departments for restricted majors shall remain in place and not be affected by this change. This also does not affect the University's requirement for a minimum GPA of 2.0 for graduation.

Discussion

- Hastings: major mistake, because some students just don't apply themselves, more and more departments will put up their own restrictions
 - Parcels: students need to be able to change majors if they can't handle their current major
 - Chajes recognizes John Morgan: UG below 2.0 should speak to an advisor in major before transferring into program
 - Lynn Worden: students below 2.0 have to speak to an advisor before registering
 - Parcels: commitment to Delawareans requires us to give students flexibility
 - Eidelman: many students take advantage of second chance
 - Matt recognizes Jose Riera: significant systemic issue, this is something that needs to be done to help students be successful
 - Departments can initiate their own restrictions
 - Call for question: approved 34-1
 - Vote on resolution: approved 37-2-1
